The SMU School of Law undergraduate curriculum leads to the award of the degree of Bachelor of Laws. The objective of this programme is to produce law graduates who have contextualized legal expertise and the ability to think across disciplines and geographical borders. In terms of pedagogy, SMU's seminar-style learning will be put to good effect to nurture students who are confident, articulate and analytically agile.

To hone the legal writing skills of the students, from Year 2 onwards, each student will be required to submit a substantial individual written assignment of about 2,000 to 3,000 words for one of the law courses read in each term.

Internship Programme

The Internship Programme consists of a 10-week attachment with a law firm, the legal department of Government Linked Corporations/Multi-National Corporations, or a public sector or public sector regulatory body and a 2-week (80-hour) attachment at a Voluntary Welfare Organisation (VWO) or organisations involved in pro bono and legal aid work. Other organisations, bodies and companies may be added to the Internship Programme and 2-week attachment from time to time.

As the details of the organisations and the time spent in each organisation will be reflected in the transcript, students must ensure that they have fulfilled the full 12 weeks before filing for graduation.

The Office of Career Services (OCS) provides all the necessary support for matters pertaining to the internship programme. You are welcome to use your own initiative to get internships on your own. However, it must be endorsed by the OCS.

- 10-week attachment

Students can start their internship anytime after completing four terms. However, it must be carried out on a full-time basis. As part of the training, students are required to source for their own placements, or browse through the online job listing available at the Office of Career Services.

Students must submit an overall report to the OCS on the scope of work and time spent in the organisations during the attachment. Organisations providing the attachment will also provide feedback to the OCS on students' performance.

- 2-week (80-hour) attachment

All students are required to complete a minimum of 80 hours of community service attachment. The community service attachment with the VWOs could be undertaken anytime during your course of study though we recommend that you do so in your first year. For community service attachments with the organisations involved in pro bono and legal aid work, students have to complete at least one term. You may work in more than one organisation if you want a breadth of experience but in any case, it should not be more than three organisations to fulfil the requirement.

Students are required to submit a written report through SMU OnTRAC after having completed the full 80-hour attachment. Host organizations are required to do a performance appraisal for our students too. Please refer to <http://ontrac.smu.edu.sg> for more information.

DOUBLE DEGREE PROGRAMME (DDP)

The School of Law offers an opportunity for outstanding SMU students to enrol in the law double-degree programmes (DDP). The law DDP is only available to a small number of very good students on a competitive basis, **and is by invitation only**. It entails five years of full-time study, and the number of law electives that the students must read will be the same as for the single degree. Some law DDP students may have to undertake two internships to meet both degrees' requirements. For example, a LL.B – BAcc DDP or a LL.B – BSc (ISM) DDP student would have to undertake a law internship as well as an accountancy or an information systems management internship respectively. Law students applying for DDP would require a good pass in Mathematics at H1 level.

Under the double degree programme, a student can graduate in five years with two degrees in:

- Law & Accountancy (LL.B & BAcc)
- Law & Business Management (LL.B & BBM)
- Law & Economics (LL.B & BSc (Econ))
- Law & Information Systems Management (LL.B & BSc (ISM))
- Law & Social Sciences (LL.B & BSocSc)
